HE AHA TE PĀNGA O TE WHAKATAU ĀE / KĀO KI TŌ HAPORI?



Ki te **ĀE** ngā pōti, ka tukuna te pire e marohitia nei ki tētahi tukanga kōmiti whiriwhiri. Hei reira e tautohea ai, e whiriwhiria ai hoki te pire i te pāremata. Ki te whakaturetia, ka whakamanatia te hokonga me te kainga o te rauhea. Ahakoa tērā, ka whakaturetia he waeture he here anō hoki hei whakahere i te mākete rauhea, ā, ka mate anō kia ūruhina.

Ki te **KĀO** ngā pōti i te tāpaetanga pōti rauhea, kāore ngā ture rauhea e tīnīhia. I tēnei tūāhua, e rua ngā pire e here ana i te whakamahinga o te rauhea, arā, te 1975 Misuse of Drugs Act, me te 2019 Misuse of Drugs Act Amendment.

Mō ngā hapori, he maha kē pea ngā painga ka hua ake i te whakaturetanga. Mō te hunga pakeke kei runga ake i te 20 tau te pakeke, ka māmā ake te āheinga ake ki ngā taonga hoko rauhea e haumaru ake ana, e ture ana hoki. Waihoki, tērā ngā āheinga ka puare ki ngā tāngata takitahi rātou ko te hunga kua whiua mō te pupuri rauhea kia uru ki tētahi mākete rauhea whaimana.

HE AHA TE KAUPAPA HERE PŪROI?

E ārahi ana te Kaupapa Here Pūroi i tā te motu whakahaere i te whakaratonga me te whakamahinga o ngā pūroi e te marea. Ko te whāinga matua o te kaupapa here pūroi a Aotearoa he whakaiti i te nui o ngā raruraru hauora, pāpori hoki e ara ake ana i ngā pūroi. Ko ngā ture me ngā waeture pūroi me ngā whakaarotau mō te whakaritenga, me ngā pānui hauora me ngā whakataunga rongoā, haumanu rānei ētahi wāhanga o te kaupapa here pūroi. E whakamāramatia ana ēnei i te National Drug Policy 2015-2020, me ngā ture mō te wainiro me te tuneka me ngā pūroi kore mana.

Engari, e āhei ana ngā ture pūroi ki te whakaheke i ngā raru, hei tauira, mā te whakaheke i te nui o ngā pūroi e wātea ana, mā te uta i ngā tepenga mō te taraiwa-haurangi me te whakarite tau iti rawa atu mō te hoko waapiro. E noho haumaru ai ō tātou hapori, he mea nui kia arotahi ake ki te hanga ture pūroi taurite, hauora hoki, ā, me whakangao pūtea tonu ki ngā ratonga hauora, pāpori hoki e whai hua ana.
